- B. The Board's custom is to ask members of the public to speak when the agenda item of interest to the person is called. Members of the public who wanted to address the Board on an issue not on the agenda were invited to speak prior to the adjournment. No one requested to speak.

Respondent was not present. This complaint involved pain management in an emergency room setting. After discussion and consideration, the Board determined there was no statute violation.

2. Jack Wolfson, D.O. Case No. DO-15-0017A License No. 3761

Respondent was present but declined to speak on advice of his attorney. This case involved 38 complaints regarding Respondent's comments during interviews with national news programs. No complainants were present at the meeting.

Dr. Cunningham moved to enter Executive Session for the purpose of legal advice. Dr. Steingard seconded. The Board entered Executive Session at 8:20 a.m. and returned to Open Session at 8:30 a.m.

The Board acknowledged in addition to the 38 formal complaints, it had received communication from numerous people, some who agreed with the Respondent's publically expressed opinion and most who disagreed. The Board expressed concern regarding the manner in which the Respondent expressed his opinion. No complaints have been filed by patients regarding the Respondent's actual medical care. The complaints received were all regarding the Respondent's publically stated opinion. The Respondent's right to express his opinion is protected by the First Amendment. The Board determined there was no statute violation.
