**MINUTES OF THE TELEPHONIC PUBLIC BOARD MEETING OF

**1. CALL TO ORDER**

Dr. Steingard called the meeting to order at 5:34 p.m.

**2. ROLL CALL AND REVIEW OF AGENDA**

The Executive Director took the roll. Five Board members were present telephonically or at the Board office, establishing quorum for the meeting. The Executive Director reviewed the agenda.

**3. CALL TO THE PUBLIC**

No members of the public were present.

**4. REVIEW, DISCUSSION AND POSSIBLE ACTION ON RECONSIDERATION AND MODIFICATION OF BOARD ORDERS OR CONSENT AGREEMENTS**

**A. Aaron Love, D.O.**

Ms. Jones reviewed the case and referred the Board to Dr. Reiss as he requested the Board reconsideration of this matter. Dr. Reiss felt that further testing regarding possible character or his behavior was not warranted and was not the standard the Board uses in these cases. He did not want to set a new precedent and was not comfortable with the outcome at the last meeting. He said there is no mention of character pathology and he did not evaluate the patient. He recommended the Board rescind the Order that was voted on at the last phone meeting for further evaluations.

**MOTION:** Mr. Landau moved to reconsider the request for personality and cognitive testing and to vacate that order. Dr. Cunningham seconded.

**VOTE:** Roll call vote, all ayes. Motion passed 5-0.

**MOTION:** Dr. Reiss moved to offer a Interim Consent Agreement which would lift the practice restriction but Dr. Love agrees to continue treatment with his psychiatrist and continue in individual psychotherapy. Dr. Love will have these two health care providers provide quarterly reports to the Board. Dr. Cunningham seconded.

**VOTE:** Roll call vote, all ayes except Mr. Landau and Dr. Steingard. Mr. Landau noted he disagrees with the Sapp report and felt it was biased. Motion carried 3-2.
