**1. CALL TO ORDER not before 8:05 a.m.**

Dr. Douglas Cunningham, Board President, called the meeting to order at 8:05 a.m. and read the Board's mission statement: "The mission of the Board is to protect the public by setting educational and training standards for licensure, and by reviewing complaints made against osteopathic physicians, interns, and residents to ensure that their conduct meets the standards of the profession, as defined in law (A.R.S. § 32-1854)."

Dr. Cunningham welcomed Christopher Spiekerman, DO, as a new member of the Board.

**2. ROLL CALL AND REVIEW OF AGENDA**

The Executive Director took the roll. Six (6) board members were present, establishing quorum for the meeting. The Executive Director reviewed the agenda.

### 3. CALL TO THE PUBLIC

- A. Dr. Cunningham welcomed the Medical Students from Arizona College of Osteopathic Medicine at Midwestern University, A.T. Still University Kirksville College of Osteopathic Medicine and A.T. Still University School of Osteopathic Medicine in Arizona.
- B. The Board's custom is to ask members of the public to speak when the agenda item of interest to the person is called. Members of the public who wanted to address the Board on an issue not on the agenda were invited to speak prior to the adjournment.

No public members addressed the Board.

A. DO-16-0017A Richard Alan Gunovich DO License No. 005110

The Respondent was not present. After discussion and consideration, the Board determined there was no statutory violation.

**MOTION:** Dr. Sabeeh moved for **Dismissal**. Dr. Reiss seconded.

**VOICE VOTE:** The motion carried unanimously.

B. DO-16-0002A Thomas G Kotoske DO License No. 3065

The Respondent was present with attorney Kimberly Kent. Respondent answered the Board's questions. After discussion and consideration, the Board determined there was no statutory violation.

**7. REVIEW, DISCUSSION AND ACTION ON INVESTIGATIVE HEARINGS PURSUANT TO A.R.S. § 32-1855(E) ONLY.**

A. DO-16-0063A Aaron Jon Mickelson DO License No. 006572

The Respondent was present with attorney Mark DuBiel and was sworn in by the court reporter. The Investigator reviewed the case. The Respondent self-reported a DUI charge which was later reduced to reckless driving. Respondent and Mr. DuBiel answered the Board's questions.

**MOTION:** Dr. Erbstoesser moved for **Dismissal**. Dr. Reiss seconded.

**VOICE VOTE:** The motion carried unanimously.

B. DO-16-0051A Doran James Schneider DO License No. 4194

The Respondent was present and was sworn in by the court reporter. The Investigator reviewed the case. The complaint alleged inappropriate behavior with coworkers.

Mr. Landau moved to enter Executive Session to review records and receive testimony regarding records which are confidential by statute. Dr. Spiekerman seconded. The Board entered Executive Session with Respondent at 9:33 a.m. and returned to Open Session at 9:59 a.m.

**MOTION:** Mr. Landau moved for a non-disciplinary **Consent Agreement** for 20 hours non-disciplinary Continuing Medical Education in the area of boundaries to be approved by the Executive Director and completed by September 2017; to get a physical exam within 90 days with results to be submitted to the Board; to continue with psychiatrist on a monthly basis; and to return at the September 2017 meeting for follow up. Dr. Erbstoesser seconded.

**VOICE VOTE:** Motion carried unanimously.

C. DO-16-0028A Christian Kline Peters DO License No. 1203

The Respondent was present with attorney Peter Akmajian and was sworn in by the court reporter. The Medical Consultant reviewed the case. The complaint alleged dispensing controlled substances without a dispensing registration and prescribing the same to himself and family members. The Respondent answered the Board's questions.

Dr. Reiss moved to enter Executive Session to review records and receive testimony regarding records which are confidential by statute. Mr. Landau seconded. The Board entered Executive Session with Respondent and Mr. Akmajian at 10:03 a.m. and returned to Open Session at 10:32 a.m.

The Board recessed for a break at 10:32 a.m. and returned to Open Session at 10:34 a.m.

Mr. Akmajian addressed the Board's questions. The Board expressed concern for Respondent's judgment in that the inappropriate prescribing continued for such a long period of time.

Dr. Reiss moved to enter Executive Session to obtain legal advice. Mr. Landau seconded. The Board entered Executive Session at 10:47 a.m. and returned to Open Session at 10:50 a.m.

The Board directed staff to complete a random 10 chart review, inspect Dr. Peter's office, and obtain medical records from his psychiatrist and primary care physician.

The case was continued pending completion of the above.

D. DO-16-0141A Kenny Khiem-Huy Mai DO License No. 006199

The Respondent was present and was sworn in by the court reporter. The Medical Consultant reviewed the case. The complaint alleged Respondent did not perform a complete physical exam and behaved rudely to a patient. Respondent answered the Board's questions.

**MOTION:** Mr. Landau moved for a non-disciplinary **Letter of Concern** for failure to conduct a complete examination, and to issue a non-disciplinary order for 20 hours of **Continuing Medical Education** in the areas of interaction with patients and conducting a physical examination to be approved by the Executive Director and to be completed by July 1, 2017. Dr. Reiss seconded.

E. DO-16-0052A Shawn Gary Platt DO License No. 3313

The Respondent was present with attorney Stephen Myers and was sworn in by the court reporter. The Investigator reviewed the case. The complaint alleged that the patient was refused care even though he was ill because he was late to his appointment. Respondent answered the Board’s questions. After discussion and consideration, the Board determined there was no statutory violation.

**MOTION:** Dr. Cunningham moved for **Dismissal**. Dr. Spiekerman seconded.

**VOICE VOTE:** The motion carried unanimously.

F. DO-14-0301A John Howard Dumbolton DO License No. 3568

The Respondent was not present. The Executive Director informed the Board that Respondent’s attorney called the day before and offered to enter into a Consent Agreement for practice restriction from emergency medicine but which will allow him to do pension and disability assessments. Further, the Respondent is in the process of seeking a re-evaluation from CPEP.

The Board directed staff to draft the Consent Agreement. The matter was tabled until the next Board meeting.

**8. REVIEW, DISCUSSION AND ACTION ON INVESTIGATIVE HEARINGS PURSUANT TO A.R.S. § 32-1855(E) ONLY. The cases in this section were called after 1:00 p.m.**

G. DO-14-0279A Teresa Marie Borchers DO License No. 3681

The Respondent was present with attorney Kenneth Gregory and was sworn in by the court reporter. The Medical Consultant reviewed the case. The complaint alleged failure to conduct a physical exam and provide adequate care. Respondent answered the Board’s questions.

Dr. Sabeeh moved to enter Executive Session to obtain legal advice. Mr. Landau seconded. The Board entered Executive Session at 1:55 p.m. and returned to Open Session at 2:06 p.m.

Ms. Sara McClure, a former employee of Respondent’s practice, was sworn in by the court reporter. She answered the Board’s questions. Ms. McClure stated her job title had been Assistant Supervisor. Ms. McClure stated she was not certified as a Medical Assistant or Billing Coding specialist but was required to substitute as both for Respondent and Dr. Goldstein-Charbonneau. She stated she and the entire staff were ordered by Joyce Michie to avoid Respondent and not speak to her. She stated she was ordered to double-, triple, and quadruple-book Respondent’s patient appointments by Dr. Goldstein-Charbonneau. Ms. McClure also stated she had been ordered to alter Respondent’s patient charts and upcode all billings.

Dr. Mark Collins, certified forensic consultant, was sworn in by the court reporter. He presented evidence and provided his opinion that the signature on the superbill in question had a high probability of being a forgery and was cut and pasted to other superbills.

The Board expressed concern regarding poor documentation in the medical record, the Respondent’s treatment of a diabetic patient, and that she was practicing family medicine when her training was in obstetrics and gynecology.

**MOTION:** Mr. Landau moved for a finding of unprofessional conduct for violation of ARS 32:1854(6), (36) & (38) for failing to perform an initial exam for a year, failed to refer patient for ophthalmology, dental, dietetics, failed to provide education in diabetic management, failed to document medication, examination and discussions with patients, failed to document patient care to a satisfactory level and that she fell below the community standard of care. Dr. Spiekerman seconded.

**VOICE VOTE:** The Motion carried unanimously.

**MOTION:** Mr. Landau moved for a disciplinary **Administrative Warning** for the conduct previously stated and 20 hours Continuing Medical Education in the area of diabetic management, 10 hours in endocrine management, 10 hours in medical record keeping, and 10 hours in cardiology, to be approved by the Executive Director and completed by the end of calendar year 2017. Dr. Erbstoesser seconded.

**MOTION:** Mr. Landau moved for Dismissal of other allegations. Dr. Erbstoesser seconded.

**VOICE VOTE:** The motion carried unanimously.

H. DO-15-0213A Teresa Marie Borchers DO License No. 3681

The Respondent remained sworn in. The Medical Consultant reviewed the case. The complaint alleged unprofessional behavior in the work place. The Medical Consultant performed a random chart review which indicated inappropriate prescribing and overprescribing, poor medical record keeping, failure to refer to specialists and failure to conduct physical exams.

Dr. Cunningham moved to enter Executive Session to obtain legal advice. Mr. Landau seconded. The Board entered Executive Session at 3:04 p.m. and returned to Open Session at 3:11 p.m.

Mr. Gregory addressed the Board and requested the mitigating circumstances regarding the adverse situation in the practice be considered. The Medical Consultant asked Respondent if she was aware that Ms. McClure was ordered to alter Respondent's patients' charts. She stated she had not known it was occurring until she received a copy of the Investigator's report.

The Respondent answered the Board's questions regarding patient care.

Ms. McClure stated Ms. Michie installed video and audio surveillance in the halls and staff areas but not in exam rooms. The Board expressed concern that the audio could pick up discussion of patient care if exam rooms were open, in the halls, the Medical Assistants' desk area and the front desk area.

Charlotte Cunningham was present as patient L.R.'s caregiver. She stated that the Respondent saved L.R.'s life after an accident that left L.R. severely disabled. She stated the Respondent was the only one in the area willing to provide care.

**MOTION:** Mr. Landau moved for a finding of Unprofessional Conduct for violation of A.R.S. (6), (36), (37) and (38) for failure to order urine drug screens, failure to maintain appropriate records, inappropriately prescribing and taking controlled substances, failure to refer where appropriate, dispensing controlled substances without a dispensing registration, and to incorporate findings of the Medical Consultant from both her report and chart reviews. Dr. Spiekerman seconded.

**VOICE VOTE:** The motion carried unanimously.

**MOTION:** Mr. Landau moved to amend his previous motion to add failure to query the CSPMP. Dr. Spiekerman seconded.

**VOICE VOTE:** The motion carried unanimously.

Dr. Sabeeh moved to enter Executive Session to obtain legal advice. Dr. Erbstoesser seconded. The Board entered Executive Session at 4:06 p.m. and returned to Open Session at 4:10 p.m.

**MOTION:** Mr. Landau moved for **Suspension** of the license for nine months; complete a CPEP, PACE or equivalent practice assessment with emphasis on general family practice and opioid prescribing to be approved by the Executive Director and completed within six months. When board receives the evaluation, Respondent is asked to come before Board to review results.

The Respondent requested to withdraw his license application.

**MOTION:** Mr. Landau moved to accept the withdrawal. Dr. Cunningham seconded.

**VOICE VOTE:** The motion carried unanimously.

B. DO-16-0258A Douglas Iddings, DO

The Respondent was present. The Executive Director's summary of the license application was reviewed. The Respondent answered the Board's questions.

**MOTION:** Dr. Sabeeh moved to approve the license application. Dr. Spiekerman seconded.

**VOICE VOTE:** The motion carried unanimously.

This application review was continued.

The Respondent was present with attorney Steven Perlmutter, MD, JD. The Executive Director reviewed the license application. The Respondent answered the Board's questions.

**MOTION:** Dr. Sabeeh moved to approve the license application. Dr. Spiekerman seconded.

## **10. REVIEW, CONSIDERATION AND ACTION ON REPORTS FROM EXECUTIVE DIRECTOR, BOARD MEMBERS, and ASST ATTORNEY GENERAL**

### A. Report on ED Dismissed Complaints

Ms. Jones reported that there were 15 Executive Director Dismissals between November 15, 2016 and January 18, 2017. Also during this time period, the Board resolved a total of 37 cases. She provided a written report to the Board members with the statutorily required information.

Dr. Spiekerman agreed to serve on case review Committee A.

### B. President and Board Member Reports

Mr. Landau reported that he and Dr. Steingard would be attending a Federation of State Medical Boards (FSMB) meeting in two weeks.

### C. Executive Director Report

#### 1. Financial Report

Ms. Jones submitted the report to the Board.

#### 2. Summary of current events that affect the Board.

Ms. Jones reported that during a recent meeting with DOA, the healthcare boards were informed that the scheduled move to 1740 W. Adams Street had been pushed back to December 2017.

Mr. Landau, Dr. Cunningham and Ms. Jones stated their intent to attend the FSMB Annual Meeting in April 2017. Dr. Spiekerman and Dr. Erbstoesser voiced interest in attending.

#### 3. Legislation Update

##### a. SB1028 - Osteopathic Continuation

Ms. Jones reported this Bill was scheduled to be considered Wednesday before the Senate Health Committee. Ms. Jones stated that Senator Barto was the Bill's sponsor.

##### b. SB1123 - Lobbyist Restriction

Ms. Jones reported this Bill, which will restrict Boards from hiring lobbyists, was introduced.

##### c. HB2195 - Medical Board

Ms. Jones reported that temporary licensure was addressed in this Bill.

d. HB2284 IT Consolidation Purchasing

Ms. Jones reported this Bill was introduced, which would consolidate all IT services and purchases.

Ms. Jones reported that the change in Statute regarding fingerprinting has been drafted to be in compliance with federal requirements. It is expected to be introduced by January 30, 2017.

4. Rules Update

Ms. Jones reported that a Rules package based on the Auditor General report is currently pending and cannot be amended at this stage.

- D. Board may review, discuss and take action on Governor Ducey's request for the Board to require one of the forty CME hours biennially required per renewal cycle be in the area of addiction or SAMHSA-supported opioid prescribing.

The Executive Director reviewed Governor Ducey's letter. The Board discussed the importance of addressing this problem and commended the Governor for taking action.

**MOTION:** Mr. Landau moved to request an exemption and then to open a Rules package to address this change. Dr. Cunningham seconded.

**VOICE VOTE:** The motion carried unanimously.

**11. REVIEW, CONSIDERATION AND ACTION ON MATTERS HEARD AT THE OFFICE OF ADMINISTRATIVE HEARINGS**

- A. DO-14-0049A Lynne Burse Pirie License No. N/A

This case was called at 11:15 a.m. Dr. Spiekerman was recused.

Dr. Pirie was not initially present, but arrived at 11:20 a.m. and addressed the Board. Mr. John R. Tellier, Asst Attorney General, was present to provide the Board with legal advice. The Board considered the Administrative Law Judge Decision in this case. Mary Williams, Asst Attorney General, Licensing and Enforcement Section, represented the State of Arizona.

The Board reviewed the Administrative Law Judge's recommendation. Ms. Williams recommended the Board adopt the Administrative Law Judge's recommendation in its entirety and affirm denial of Ms. Pirie's license application.

**MOTION:** Mr. Landau moved to adopt Findings of Fact, Conclusions of Law and the Order of Administrative Law Judge Thomas Shedden in Case No. 16A-D014-0049A-OST in the matter of Lynn Pirie. Dr. Erbstoesser seconded.

**ROLL CALL VOTE:** The motion carried 5-0.
