8. REPORTS FROM EXECUTIVE DIRECTOR, BOARD MEMBERS, and ASST ATTORNEY GENERAL

A. Report on ED Dismissed Complaints

Ms. Jones, Executive Director, reported that from March 23, 2013 through May 13, 2013, twenty-three (23) cases had been closed by ED dismissal. A listing of the statutorily required information was included in the Board’s materials prior to the meeting.

B. President and Board Member Reports

No reports were made at this time.

C. Executive Director Report

1. Budget

Ms. Jones reported that a complete copy of the agency’s revenue and expenses was provided to the members in their packets. At this point the Board is within their appropriation and slightly under budget for this point in the year. Additional expenses will be incurred with the security upgrades to the office.

2. Complaint Status

Ms. Jones reported there are 204 pending complaints at this time.

3. Updates on building security and 2014 proposed schedule

Ms. Jones reported that the security measures for the lobby area required immediate approval and she has moved forward on that project. The cost increased significantly with the addition of the bullet resistant materials but it is what the Risk Management survey recommended. In order to

afford the increased cost, a portion of the project will be paid for in funds from this fiscal year's budget and the balance out of next year's budget. The project should be completed this summer.

D. Board may review, discuss and take action on approval of revised application.
