**1. CALL TO ORDER**

**3. CONSIDERATION AND ACTION ON COMPLIANCE WITH TERMS OF BOARD ORDERS AND REQUESTS TO MODIFY OR TERMINATE ORDERS, PURSUANT TO A.R.S. §32-1855 (E) and (I).**

A. Steven J. Locnikar, DO Case No. DO-10-0022A License No. 005284

Dr. Locnikar was present. Dr. Locnikar requested that the term of his Board Order which prohibits him from being on call be lifted. After discussion, the Board asked Dr. Locknikar to provide documentation from his potential employer regarding the job's description and duties. The case was tabled until Dr. Locknikar can provide the additional information for further consideration by the Board.

B. Donald Sansom, DO Case No. DO-12-0065A License No. 2995

Dr. Sansom was present. Dr. Sansom answered the Board's questions. A draft of a Consent Agreement for Probation was presented by the Executive Director for consideration.

**MOTION:** Dr. Picardo moved to accept the Consent Agreement pending an updated report from his treating psychiatrist. Limitations included his practice would be limited to Urgent Care, he may not practice anesthesia. In addition, he may practice up to twenty (20) hours per week with a maximum shift of ten (10) hours in duration and may only work day shifts. He will need to practice under the supervision of another physician for the first thirty (30) calendar days. Dr. Cunningham seconded.
